# Clifton-Allen Lodge Reconsecrated



Most Worshipful Brother Keith W. Newton, Grand Master of Free & Accepted Masons of Ohio, with the assistance of his Officers and Past Masters of Clifton-Gaston Allen Lodge, reconsecrated the Lodge on Saturday, August 8, commemorating the 100th Anniversary of Clifton Lodge's chartering on October 22, 1920. The ceremony was originally scheduled for April but was postponed by the COVID-19 pandemic.

Following the Reconsecration, the Grand Master attended

a ceremony in our Temple Ballroom recognizing the Masters of Lodges in the 16th, 22nd and 25th Masonic Districts together with Excellence in Youth and Grand Master's Community Service Awardees who would have been recognized at the respective Grand Master's Receptions which were similarly cancelled in the Spring. The event was complete with a box lunch (per government COVID-19 precautions) provided by the Blue Lodge Associations of the 22nd Masonic District. It was a great day for Freemasonry in Lakewood and Northern Ohio!

While on the subject of reconsecrations, we note with some sadness that Holy Grail Commandery's 100th Anniversary Reconsecration by the Grand Commandery, Knights Templar of Ohio, originally scheduled for Sunday, September 20, 2020, has been postponed indefinitely per the COVID-19 precautions ordered by the Grand Encampment of Knights Templar, USA.

#### **CARES Act Offers Larger Tax Deductions**

The CARES Act government stimulus bill was adopted last spring to help mitigate the effects of the COVID-19 pandemic. While its provisions are wide-ranging, one specific purpose was to stimulate additional charitable giving.

The federal tax reform act passed in 2017 nearly doubled the standard deduction for federal income tax purposes in an attempt to simplify tax return preparation. Many previously itemized deductions were eliminated in the process. One of the downside effects for charitable organizations such as our Lakewood Masonic Foundation was a loss of incentive for taxpayers accustomed to claiming itemized charitable deductions.

One of the CARES Act provisions is that if you take the standard deduction in 2020 (on the return you file in 2021), you can take an additional "above the line" deduction of up to \$300 for cash donations you make to charities such as our Lakewood Masonic Foundation this year.

The CARES Act further provides that if you will be itemizing your 2020 deductions, for this year only you may deduct cash donations to charities of up to 100% of your Adjusted Gross Income (AGI) rather than the usual 60% limitation (with associated carryovers).

The most important incentive for donating to our Lakewood Masonic Foundation isn't an income tax deduction. Rather, it's an expression of the donor's affection for, and support of, our Lakewood Masonic Family and our charitable purposes—a desire to contribute above and beyond your annual dues.

In addition to cash donations (yes, including checks), our other donation vehicles are still available to you.

**AmazonSmile** shoppers (smile.amazon.com/ch/20-0357206) can have 0.5% of their purchases donated to our Lakewood Masonic Foundation without increasing the price paid for purchases.

**Facebook** users may donate through our Facebook page. Facebook does not charge a fee to our Lakewood Masonic Foundation or other not-for-profit organizations.

**Traditional (not Roth) IRA holders** may still donate directly from their IRAs, although the required minimum distributions (RMDs) for older account holders have been eliminated for 2020. Such distributions do not incur either federal income or estate taxes but also do not count as itemized deductions for tax purposes.

Donations can be made after death by naming The Lakewood Masonic Foundation as a beneficiary in your will, life insurance policy, IRA, TOD (Transfer on Death) account or the like, either as a fixed amount or a percentage.

In all tax matters, you are best advised to discuss your intentions with an attorney and/or tax accountant. Gifts and bequests to our Lakewood Masonic Foundation (but not our Lakewood Masonic Temple Operating or Endowment Funds) are deductible for federal estate and income taxes to the extent permitted by law.

#### Representatives of Lodges

In the General Regulations of 1721 it was enacted that "The Grand Lodge consists of and is formed by the Masters and Wardens of all the regular particular Lodges on record"; and also that "The majority of every particular Lodge, when congregated, shall have the privilege of giving instructions to their Master and Wardens before the assembling of the Grand Chapter or Lodge, at the three quarterly communications hereafter mentioned and of the Annual Grand Lodge too; because their Master and Wardens are their Representatives and are supposed to speak their mind" (*Constitutions*, 1723, page 61). A few modern Grand Lodges have disenfranchised the Wardens also, and confined the representation to the Masters only. But Brother Hawkins asserts further that this is evidently an innovation, having no color of authority in the Old Regulations.

### **Proxy Installation**

The Regulations of 1721 provide that, if the new Grand Master be absent from the Grand Feast, he may be proclaimed if proper assurance be given that he will serve, in which case the old Grand Master shall act as his proxy and receive the usual homage. This has led to a custom, once very common in the United States, but later on getting into disuse, of installing an absent officer by proxy. Such installations are called *Proxy Installations*. Their propriety is truly very questionable.

### Commander's Message

Sir Knights:

We hope you are safe and well. By order of our Grand Encampment, we have not met in-person since our March conclave; and it seems doubtful that in-person Commandery events will resume in 2020. But we'll see.

In the meantime, using the procedures authorized by our Grand Encampment, Grand Commandery and Grand Lodge, we held two virtual conclaves, one in May for our elections, and one in June for our Annual Conclave and Installation of Officers. Virtual conclaves via Zoom appear to be around for a while longer. The annual Grand Commandery in October is cancelled as an in-person event, to be replaced by a virtual session to conduct necessary business.

In the meantime, you are encouraged to stay active in your Lodge and other Masonic memberships, whether in-person or electronically.

#### Palm and Shell, Oriental Order of the

The object of the Masonic Holy Land League, in whose membership the Pilgrim Knights of the Palm and Shell were enrolled, was to encourage researches commenced in 1863 under the leadership of Brother Rob Morris in the Holy Land. These investigations into the traditions and practises of the ancient Craft in the East, were supported in 1867 by contributions amounting to \$10,000.00 and an organization was effected of Master Masons. A ritual was prepared to include various signs, words and ceremonies, obtained by Doctor Morris from Eastern Freemasons. The instruction was divided into the following parts: Preliminary, Covenanting, Drama, Means of Recognition, and a funeral ceremony for Pilgrim Knights. Rev. Henry R. Coleman, of Kentucky, became Supreme Chancellor of the Order and in 1906 he published at Louisville, for the Society, a guide to the ceremonies and lectures entitled the *Pilgrim Knight*. Among other items of interest he describes the formation of a Lodge, the Royal Solomon, at Jerusalem, conditionally promoted by Doctor Morris in 1868, but actually authorized (see page 27) by a Warrant from the Grand Lodge of Canada, William Mercer Wilson, Grand Master, and attested by Thomas White, Jr., Deputy Grand Master, on February 17, 1873; the organizing meeting occurring in the quarries under Jerusalem on May 7, 1873. Brother Coleman says (page 29): "Under this authority, a delegate went from the United States to Jerusalem and calling together a competent number of those named in the Warrant, and others, the Lodge was regularly and constitutionally organized and has had many years of prosperous existence up to the issuance of this volume." The first Degree was conferred at the Mediterranean Hotel, after which a Lodge-room was established near the Joppa Gate.

#### **Sloane Manuscripts**

There are three copies of the *Old Constitutions* which bear this name. All of them were found in the British Museum among the heterogeneous collection of papers which were once the property of Sir Hans Sloane.

The first *Sloane Manuscript*, which is known in the Museum as No. 3848, is one of the most complete of the copies extant of the *Old Constitutions*. At the end of it, the date is certified by the following subscription: *finis p. me Eduardu Sankey decimo sexto die Octobris Anno Domini 1646*. It was published for the first time, from an exact transcript of the original, by Brother Hughan in his *Old Charges of the British Freemasons*.

The second *Sloane Manuscript* is known in the British Museum as No. 3323. It is in a large folio volume of three hundred and twenty-eight leaves, on the fly-leaf of which Sir Hans Sloane has written, "Loose papers of mine Concerning Curiosities." There are many manuscripts by different hands. The Masonic one is subscribed thus with the date and name of the writer, *Haec scripta fuerunt p. me Thomam Martin, 1659*, and this fixes the date. It consists of three leaves of paper six inches by seven and a half, is written in a small, neat hand, and endorsed *Free Masonry*. It was first published, in 1871, by Brother Hughan in his *Masonic Sketches and Reprints*. The Rev. Brother A. F. A. Woodford thinks this an "indifferent copy of the former one." But this seems unlikely. The entire omission of the Legend of the Craft from the time of Lamech to the building of the Temple, including the important Legend of Euclid, all of which is given in full in the other manuscript, No. 3848, together with a great many verbal discrepancies, and a total difference in the eighteenth charge, would lead one to suppose that the former manuscript never was seen, or at least copied, by the writer of the latter. On the whole, it is, from this very omission, one of the least valuable of the copies of the *Old Constitutions*.

The third *Sloane Manuscript* is really one of the most interesting and valuable of those that have been heretofore discovered. A portion of it, a small portion, was inserted by Findel in his *History of Freemasonry*; but the whole has been since published in the *Voice of Masonry*, a periodical printed at Chicago in 1872. The number of the manuscript in the British Museum is 3329, and Brother Hughan places its date at from 1640-1700; but he says that Messrs. Bond and Sims, of the British Museum, agree in stating "that it is probably of the beginning of the eighteenth century." But the Rev. Brother Woodford mentions a *great authority*, Wallbran, on manuscripts who declares it to be "previous to the middle of the seventeenth century." Findel thinks it originated at the end of the seventeenth century, and "that it was found among the papers which Doctor Plot left behind him on his death, and was one of the sources whence his communications on Freemasonry were derived." It is not a copy of the *Old Constitutions*, in which respect it differs from all the other manuscripts, but is a description of the ritual of the Society of Free Operative Masons at the period when it was written. This it is that makes it so valuable a contribution to the history of Freemasonry, and renders it so important that its precise date should be fixed.
