Back to the Future, Lakewood Style

Remember when things were normal—pre-COVID-19 pandemic, that is?

It seems so awfully long ago, but over the past year the situation has improved to the point that most of our members have felt comfortable attending meetings and events again, perhaps keeping their distance and masking by choice.

Over the past year our Lakewood Masonic Family of organizations has conferred degrees and orders on both new petitioners and those whose membership progress was stalled by COVID closures. Whew! But what a nice problem to have.

In addition, we hosted centennial celebrations for Lakewood Council R. & S. M. and Ann Rutledge Chapter O. E. S. We hosted the Annual Meeting and Installation of Officers of Goose and Gridiron Lodge, a special interest Ohio Lodge which uses the English Emulation Ritual and travels around Ohio (and sometimes elsewhere) for its meetings.

Lakewood Masonic Temple was the proud host to this year's 22nd Masonic District Grand Master's One Day Class at which over 60 new Masons received their three Lodge degrees in a day, complete with educational presentations. Our Temple was built to accommodate large crowds, and it was thrilling to see the Banquet Room full and many Lodge Room balcony seats occupied.

Our Sunday church tenant has been meeting in person and livestreaming from our Ballroom, making full use of the facilities we have to offer.

This month saw the return of weddings, receptions and fundraisers, some of which were post-

poned from the early months of the pandemic.

But while our calendar has been slowly filling up again, expenses and projects have never stopped. Our Temple consumes natural gas and electricity even when empty, albeit at reduced levels. We took the opportunity to remediate original heating pipe insulation, replacing it with modern fiberglass. We have continued our conversion to LED lighting, most especially in our Banquet Room and rest rooms. We are in the process of updating rest rooms. And we're still staring down the major project of restoring or replacing the large triple hung windows that circle our Temple on the Ballroom and First Mezzanine levels.

So we still need your help, as you are able. Several donation options are shown on page 2. On page 11 is a form to use for donations. Gifts to our Lakewood Masonic Foundation are deductible for federal income tax purposes. Even if you use the standard deduction you can still claim up to \$300 for an individual or \$600 for a couple filing jointly without itemizing. Every gift helps!

When you shop using AmazonSmile (smile.amazon.com/ch/20-0357206), Amazon will donate 0.5% of your purchase to our Lakewood Masonic Foundation. This will not increase the price you pay for your purchases.



Facebook users may donate through our Facebook page. Facebook does not charge a fee to our Lakewood Masonic Foundation or other not-for-profit organizations.



Holders of traditional (not Roth) IRAs must begin taking required minimum distributions (RMDs) in the year they turn age 70-1/2. Distributions made directly from an

IRA to a qualified charity such as our Lakewood Masonic Foundation can count toward your required minimum distribution, subject to a collective limit of \$100,000 per year. Such distributions do not incur either federal income or estate taxes but also do not count as itemized deductions for tax purposes.



Donations can be made after death by naming The Lakewood Masonic Foundation as a beneficiary in your will, life insurance policy, IRA, TOD (Transfer on Death) account or the like, either as a fixed amount or a percentage. A will can be amended by codicils without having to be rewritten in its entirety. In matters such as these, you are best advised to discuss your intentions with an attorney and/or tax accountant.



Gifts may be in the form of cash, securities or property. Gifts of appreciated securities and/or charitable gift annuities can be especially beneficial to the donor. In matters such as these, you are best advised to discuss your intentions with an attorney and/or tax accountant.

Some employers have payroll deduction plans and/or matching gift programs for charitable giving. Check yours.

Gifts and bequests to our Lakewood Masonic Foundation (but not our Lakewood Masonic Temple Endowment Fund or our Lakewood Masonic Temple Company Operating Fund) are deductible for federal estate and income taxes to the extent permitted by law. As always, we encourage you to consult your legal and financial advisors for assistance in determining in what form and in what amount you should make any major gift or bequest.

Ballot-Box

The box in which the ballots or little balls or cubes used in voting for a candidate are deposited. It should be divided into two compartments, one of which is to contain both black and white balls, from which each member selects one, and the other, which is shielded by a partition provided with an aperture, to receive the ball that is to be deposited.

Various methods have been devised by which secrecy may be secured, so that a voter may select and deposit the ball he desires without the possibility of its being seen whether it is black or white. That which has been most in use in the United States is to have the aperture so covered by a part of the box as to prevent the hand from being seen when the ball is deposited.

High Priest's Message

Companions:

At the time of this writing my time as High Priest of Cunningham Chapter #187 is coming to an end. We have only our Annual Convocation, Installation of Officers and Awards Night to go. This has been a very successful year by a variety of standards due to the fantastic efforts of the officers and Companions of our Chapter.

During this year we were able to successfully complete all four Chapter Degrees, and exalted four new Companions. We also were able to reinstate three Companions who had previously been suspended. The success we have had the past couple of years in exalting new Companions (11 total) makes me very optimistic about the future of our Chapter.

The year was not without its challenges. We had to address the issue of non-payment of dues as well as our dues being insufficient to meet the needs of the Chapter. To that end it was decided to increase our annual dues to \$50 plus the current Grand Chapter assessment. This should make us more nimble and self-sufficient as we move into the future. As an additional reminder, annual dues for Chapter were due by May 31. If you have already paid, thank you! If not, please remit your dues as soon as possible.

I want to end by again thanking all of the officers and Companions for making my year as High Priest a pleasant and smooth one. Your efforts were fantastic and went above and beyond. Thank you!

Door

Every well-constructed Lodge-room should be provided with two doors – one on the left hand of the Senior Warden, communicating with the preparation room; the other on his right hand, communicating with the Tiler's apartment. The former of these is called the *Inner Door*, and is under the charge of the Senior Deacon; the latter is called the *Outer Door*, and is under the charge of the Junior Deacon. In a well-furnished Lodge, each of these doors is provided with two knockers, one on the inside and the other on the outside; and the outside door has sometimes a small aperture in the center to facilitate communications between the Junior Deacon and the Tiler. This, however, is a modern innovation, and its propriety and expediency are very doubtful. No communication ought legally to be held between the inside and the outside of the Lodge except through the door, which should be opened only after regular alarm duly reported, and on the order of the Worshipful Master.

Brother Mackey here describes the common practice in the United States of America, but the arrangement he advocates is by no means universal, Brother Clegg reporting instances found abroad where he entered at the left of the Senior Warden.

Master's Message

Companions:

What a great year we've had! The COVID-19 pandemic delays notwithstanding, we've accomplished so much that we expect to receive a Grand Master's Award at the Grand Council Annual Assembly in October.

We advanced seven Companions over the past year starting with back-to-back conferrals of the Royal Master and Select Master Degrees last June, followed by the conferral of the Select Master Degree for our Annual Inspection in March and culminating with an additional Select Master conferral in May. We took one candidate to the Super Excellent Master Degree conferral in Canfield last August and four more to our own joint Lakewood-Ross R. Black-Windermere Council Super Excellent Master conferral in May.

We conducted pre-degree educational sessions ahead of each of our degree conferrals, helping our candidates understand the historical perspective of each degree and its relationship to their Lodge and Chapter degrees.

We had several Companions volunteer at last summer's WonderStruck Music Festival and Medina County Fair and last November's Cleveland Christmas Connection, all for the cause of raising funds for our Diabetic Kids Fund charity.

In March we celebrated the centennial of Lakewood Council as our Grand Master, Most Illustrious Companion David Weimer, and his Grand Council officers conducted the 100th Anniversary Reconsecration ritual in our own Secret Vault. Immediately following the ceremony we hosted the 7th Arch Deputy Masters Meeting conducted by Deputy Grand Master Right Illustrious Companion Michael Terry.

Looking ahead, the reins of leadership will pass to Companion Jon Hupp at our Annual Assembly and Installation on Wednesday, June 1. Come and participate. This will be the first year since I joined in 2013 that I won't been an officer, having been Deputy Master or Master every year but one (when I was Marshal). I take this as a favorable omen—that we've grown our membership and involved more of our Companions. I trust that all our Companions will continue to give the same support to our Council that Illustrious Companion Bert Horne and I have received in our several terms as Illustrious Master.

As always, we'll be looking for volunteers to work at the WonderStruck Music Festival on Saturday and Sunday, July 9-10, and at the Medina County Fair the week of August 1-7, Monday to Sunday. Do it for the fun! Do it for our kids!

Finally, remember that petitions are the lifeblood to our Council. It's never too early to bring in a new petition, even if his Chapter degrees are still in progress.

Commander's Message

Sir Knights:

Our Annual Conclave and Installation will be held Thursday, June 2, at 7:30p, preceded by a 6:30p dinner prepared by the Ladies of Cleveland Beauceant. Aftr the short tyled conclave, the Installation will be open to invited guests.

We had a successful year and will have knighted six new members by May 31. Now is the time to bring in petitions for next year's Orders, even if they haven't completed all their Chapter degrees.

Commandery

1. In the United States all regular assemblies of Knights Templar are called *Commanderies*, and must consist of the following officers: Eminent Commander, Generalissimo, Captain-General, Prelate, Senior Warden, Junior Warden, Treasurer, Recorder, Warder, Standard-Bearer, Sword Bearer, and Sentinel. These Commanderies derive their warrants of Constitution from a Grand Commandery, or, if there is no such body in the State in which they are organized, from the Grand Encampment of the United States. They confer the Degrees of Companion of the Red Cross, Knight of Malta, and Knight Templar. Under the present law of the Grand Encampment, Knight Templar of the United States, the Order of the Red Cross is conferred in the *Council Chamber*, the Order of Malta in a *Priory* and the Order of the Temple in the *Asylum of the Commandery*.

In a *Commandery of Knights Templar*, as familiar to Doctor Mackey, the throne is situated in the East. Above it are suspended three banners: the center one bearing a cross, surmounted by a glory; the left one having inscribed on it the emblems of the Order, and the right one, a paschal lamb. The Eminent Commander is seated on the throne; the Generalissimo, Prelate, and Past Commanders on his right; the Captain-General on his left; the Treasurer and Recorder, as in a Symbolic Lodge; the Senior Warden at the southwest angle of the triangle, and upon the right of the first division; the Junior Warden at the northwest angle of the triangle, and upon the left of the third division; the Standard-Bearer in the West, between the Sword-Bearer on his right, and the Warder on his left; and in front of him is a stall for the initiate. The Knights are arranged in equal numbers on each side, and in front of the throne. In England and Canada a body of Knights Templar is called a *Preceptory*.

2. The houses of residences of the Knights of Malta were called *Commanderies*, and the aggregation of them in a nation was called a *Priory* or *Grand Priory*.

Corn, Wine, and Oil

Corn, wine, and oil are the Masonic elements of consecration. The adoption of these symbols is supported by the highest antiquity. *Corn, wine, and oil* were the most important productions of Eastern countries; they constituted the wealth of the people, and were esteemed as the supports of life and the means of refreshment. David enumerates them among the greatest blessings that we enjoy, and speaks of them as “*wine* that maketh glad the heart of man, and *oil* to make his face to shine, and *bread* which strenghteneth man’s heart” (Psalm civ., 15). In devoting anything to religious purposes, the anointing with oil was considered as a necessary part of the ceremony, a rite which has descended to Christian nations. The tabernacle in the wilderness, and all its holy vessels, were, by God’s express command, anointed with oil; Aaron and his two sons were set apart for the priesthood with same ceremony; and the prophets and kings of Israel were consecrated to their offices by the same rite. Hence, Freemasons’ Lodges, which are but temples to the Most High, are consecrated to the sacred purposes for which they were built by strewing *corn, wine, and oil* upon the *Lodge*, the emblem of the Holy Ark. Thus does this mystic ceremony instruct us to be nourished with the hidden manna of righteousness, to be refreshed with Word of the Lord, and to rejoice with *joy* unspeakable in the riches of divine grace.” Wherefore, my brethren,” says the venerable Harris (Discourse iv, 81), “wherefore do you carry *corn, wine, and oil* in your processions, but to remind you that in the pilgrimage of human life you are to impart a portion of your *bread* to feed the hungry, to send a cup of your *wine* to cheer the sorrowful, and to pour the healing *oil* of your consolation into the wounds which sickness hath made in the bodies, or affliction rent in the heart, of your fellow-travellers?”

In processions, the *corn* alone is carried in a golden pitcher, the *wine* and *oil* are placed in silver vessels, and this is to remind us that the first, as a necessity and the “staff of life,” is of more importance and more worthy of honor than the others, which are but comforts.

Occasional Lodge

A temporary Lodge convoked by a Grand Master, as for the purpose of making Freemasons, after which the Lodge is dissolved. The phrase was first used by Anderson in the second edition of the *Book of Constitutions*, and is repeated by subsequent editors. To make a Freemason in an Occasional Lodge is equivalent to making him “at sight.” But any Lodge, called temporarily by the Grand Master for a specific purpose and immediately afterward dissolved, is an Occasional Lodge. Its organization as to officers, and its regulations as to ritual, must be the same as in a permanent and properly warranted Lodge.


